<p>Terms &amp; Conditions</p>	<p>(i) The selected Advisor (E&amp;T) would be stationed at BCCL, Dhanbad and will be reporting to Director (Technical), BCCL.</p> <p>(ii) The engagement of Advisor (E&amp;T) shall be subject to Medical fitness to be certified by Company Medical Officer.</p> <p>(iii) Notice Period for termination of contract — one month's notice or consolidated compensation amount from either side.</p> <p>(iv) The Advisor (E&amp;T) will maintain all information / documents/ materials gathered during the course of engagement in strict confidence. He/She will not copy or make notes of such information/ documents except in conjunction with the work for the Company. He/She will not</p>
