परिपत्र/ CIRCULAR

Two posts of Mineral Economist (Intelligence) in the Level - 12 in the Pay Matrix (Rs. 78800-209200) in Indian Bureau of Mines under the Ministry of Mines is to be filled by deputation including short-term contract basis.

02. The duties in brief of Mineral Economist (Intelligence) in Indian Bureau of Mines are as under: -

“Preparation and periodical updation of National Mineral Inventory. The work involves data collection, compilation, tabulation, processing and scrutiny from different sources, synthesis, Computer data entry, output generation of deposit-wise inventory and summary output; sale of inventory, classification of reserves according to end-use; adoption and implementation of international mineral classification. Preparation and release of the Indian Minerals Year Book. This work involves data collection from consuming units, exploration units, ports, railways, beneficiation plants, etc; data processing, tabulation, scrutiny and preparation of mineral-wise reviews incorporating the details of resources, production, consumption, trade, stock, World review, use pattern, specification, etc. To conduct market surveys on mineral and metals which involves data collection by questionnaires and field visits; data compilation and processing and scrutiny. The various aspects covered in market survey reports include use patterns, industry specification, demand-supply resource position, consumption pattern, beneficiation and World markets. To collect, compile, process and analyse the data on mines, minerals, metals and mineral based industries for attending to the queries from the Government like Parliament questions, references from ministries and queries from the general public.”

03. As per the Recruitment Rules for the post of Mineral Economist (Intelligence), the candidates to be considered for appointment by deputation including short-term contract should be Officers of the Central Government or State Government or Union Territories or Autonomous or Statutory Organisation or Public Sector Undertakings or University or Recognized Research Institution:

- (A) (i) holding analogous posts on regular basis in the parent cadre or Department; or,
(ii) with five years service in the grade rendered after appointment thereto on a regular basis in post in level 11 (Rs. 67700-208700) in pay matrix or equivalent; and,

(B) possessing the following qualifications and experience :—

- (i) Masters Degree in Geology or Applied Geology or Economics or Bachelors Degree in Mining Engineering from a recognised University or institute;

- (ii) Ten years experience in the field of mineral economics, namely, conducting demand supply studies, market survey of minerals, mineral inventory, mineral legislation, world mineral intelligence, investigation of economic aspect of mineral resources and production and consumption or utilisation of minerals, analysis and dissemination of information.

Note-1: The Departmental officers in the feeder grade who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note-2: Period of deputation (including short-term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not exceed four years.

Note-3: The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this Department and NOC from the parent Department. However, the officer may also consider for pre-mature reversion to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provision contained under DoPT OM No. 6/8/2009-Estt.(Pay II) dated 17.06.2010.

05. Application containing the bio-data (in triplicate) of the officer who fulfills the above as on the closing date may be sent through proper channel addressed to **the Superintending Mining Geologist & Head of Office, 4th Floor, "D" Block, Indian Bureau of Mines, Indira Bhavan, Civil Lines, Nagpur - 440 001** in the enclosed bio-data proforma (Annexure - I) within 60 days from the date of publication of advertisement in the Employment News alongwith the up-to-date Confidential Reports/Dossiers for the preceding 5 years, Integrity Certificate, Vigilance Clearance and No Penalty Certificate for preceding 10 years of the officer concerned. Applications received after the closing date will not be entertained. Also, advance copies of application or not accompanied with all above certificates/enclosures are liable to be rejected.

06. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
